6. Terms and conditions for participation:

1. The Italian Radiation Protection Association (AIRP) and the Organising Committee Members decline responsibilities for any damage or loss during the intercomparison.
2. Laboratories must provide 20 devices for each detector set, following instructions that will be sent after the end of the subscription period. Any device not conforming to preparation instructions will be rejected.
3. The Organising Committee will take care of device shipping after exposure. Please note that all inbound shipping costs to Italy (including custom expenses for non-EU participants) must be borne by the Laboratory.
4. Participation fee: 200 € (plus VAT if applicable) for each detector set, to be paid before June, 15th. No reimbursement is foreseen, except in the case of cancellation.
5. Intercomparison results will be treated as confidential by the Organising Committee and the identification number will not be made public. Results, in anonymised form, will be presented in a specific session during a congress which will be held in LURISIA in 2015. Aggregate results, in anonymous form may give rise to a publication and/or a report, that will be sent to all intercomparison participants.
